**AN ORDINANCE TO ENACT CERTAIN TRAFFIC/PARKING REGULATIONS**

**WHEREAS**, pursuant to the City Charter and Chapter 37 of the City Code, the Department of Public Works has proposed and the City Council deems it necessary and proper to enact the traffic and parking regulations set forth herein.

**THE COUNCIL OF THE CITY OF WILMINGTON HEREBY ORDAINS:**

**SECTION 1.** That the following street be designated as a “**TWO-WAY**” traffic street:

- a. East 3<sup>rd</sup> Street, between North Lombard Street and Poplar Street.

**SECTION 2.** That “**ALL-WAY STOP**” signs be installed at the following locations:

- a. On East 25<sup>th</sup> Street intersecting Carter Street.
- b. On West 34<sup>th</sup> Street intersecting North Van Buren Street.
- c. On North Monroe Street intersecting West 35<sup>th</sup> Street.

**SECTION 3.** That “**NO TURN ON RED**” signs be installed at the following locations:

- a. On southbound King Street intersecting West 2<sup>nd</sup> Street
- b. On southbound King Street intersecting East 10<sup>th</sup> Street
- c. On eastbound East 10<sup>th</sup> Street intersecting King Street

**SECTION 4.** That “**NO PARKING THIS SIDE**” signs be installed along the westside of North Ford Avenue between West 4<sup>th</sup> Street to West 5<sup>th</sup> Street.

**SECTION 5.** That “**NO PARKING CHILD DROP OFF AND PICK UP 7:00 A.M. TO 9:00 A.M., Except Saturdays and Sundays**” signs be installed on the westside of South Connell Street beginning 45 feet from the northerly building line of Elm Street and extending 20 feet north.

**SECTION 6.** That “**NO PARKING CHILD DROP OFF AND PICK UP 4:00 P.M. TO 5:30 P.M., Except Saturdays and Sundays**” signs be installed on the westside of South Connell Street beginning 45 feet from the northerly building line of Elm Street and extending 20 feet north.

**SECTION 7.** That “**NO PARKING CHILD DROP OFF AND PICK UP 7:00 A.M. TO 6:00 P.M., Except Saturdays and Sundays**” signs be installed on the westside of South Lincoln Street beginning 40 feet south of the southerly building line of Tulip Street and extending south 45 feet.

**SECTION 8.** That “**NO PARKING CHILD DROP OFF AND PICK UP 7:00 A.M. TO 8:30 A.M., Except Saturdays and Sundays**” signs be installed on the northside of East 12<sup>th</sup> Street beginning 20 east of the easterly building line of North King Street and extending east 161 feet.

**SECTION 9.** That “**NO PARKING CHILD DROP OFF AND PICK UP 2:00 P.M. TO 3:30 P.M., Except Saturdays and Sundays**” signs be installed on the northside of East 12<sup>th</sup> Street beginning 20 east of the easterly building line of North King Street and extending east 161 feet.

**SECTION 10.** That “**NO PARKING STREET CLEANING 11:00 A.M. TO 1:00 P.M., WEDNESDAYS ONLY**” on the westside of North Dupont Street, between Delaware Avenue & Gilpin Avenue.

**SECTION 11.** That “**THIRTY-MINUTE PARKING 8:00 A.M. TO 6:00 P.M. EXCEPT SUNDAYS, BETWEEN SIGNS**” signs be installed on the westside of North Lincoln Street beginning 144 feet north of the northerly building line of Delaware Avenue and extending north 38 feet.

**SECTION 12** That the portions of legislation that designates the following be hereby **RESCINDED**:

- a. Removal of the designation of East 3<sup>rd</sup> Street between North Lombard Street and Poplar Street as a “ONE-WAY” traffic street.
- b. Removal of “TWO HOUR PARKING 8:00 AM TO 6:00PM, Except Sunday” signs on the eastside of North Broom Street beginning at the southerly building line of West 10<sup>th</sup> Street and extending south 80 feet.
- c. Removal of “TWO HOUR PARKING 8:00 AM TO 6:00PM, Except Sunday” signs on the westside of North Dupont Street between West 10<sup>th</sup> Street & West 11<sup>th</sup> Street.
- d. Removal of “TWO HOUR PARKING 8:00 AM TO 6:00PM, Except Sunday” signs on the northside of West 9<sup>th</sup> Street beginning at the westerly building line of North Dupont Street and extends west 80 feet.
- e. Removal of “TWO HOUR PARKING 8:00 AM TO 6:00PM, Except Sunday” signs on the eastside of North Broom Street beginning at the southerly building line of West 11<sup>th</sup> Street and extends south 227 feet.

f. Removal of “TWO HOUR PARKING 9:00 AM TO 4:00PM, Except Sunday” signs on the westside of North Lincoln Street between Chestnut Street and Tulip Street.

g. Removal of “NO PARKING STREET CLEANING” signs on the southside of West 9<sup>th</sup> Street between North Rodney Street and North Clayton Street.

h. Removal of “NO PARKING STREET CLEANING” signs on the southside of West 9<sup>th</sup> Street between North Rodney Street and North Broom Street.

**SECTION 13.** This ordinance shall become effective immediately upon its date of passage by the City Council and approval by the Mayor.
