10. Is it understood that the vehicle must not be overloaded and that explosives shall not be piled above the level of the sides, boards or gates of the vehicle _____.

11. Is it understood that dynamite cases shall be piled topside up, kegs on end with bungs up or on sides with seams _____.
12. Is it understood that in delivering explosives they shall not be left unless they are placed in charge of some competent person authorized to accept them _____.
13. Is it understood that congested streets are to be avoided in delivering explosives _____.
14. Is it understood that no explosives shall be carried in or upon any public conveyance, which is carrying passengers _____.
